Health Guarantee

Goshen Swamp Retrievers, Inc. makes the following limited health guarantee for the above puppy:

1. Goshen Swamp Retrievers, Inc. ("Goshen Retrievers") guarantees that the puppy is in good health at the time of sale.
2. All age appropriate shots, dewormings and treatments have been given. Records of health care are attached with this guarantee.
3. This guarantee is subject to the requirement that the Buyer have this dog examined by a licensed veterinarian of their choice within 72 hours (3 business days) from time of delivery (at the Buyer's expense). Failure to do so will void this health guarantee.
4. If within 72 hours of the sale, a licensed veterinarian finds the puppy was unhealthy at the time of sale or was unfit for sale and provides Goshen Retrievers with a written statement confirming the findings and why the puppy is a poor health risk (does not include UTI, fleas, ticks, mites, internal parasites, or something the puppy was exposed to during travel home, etc), the puppy may be returned to Goshen Retrievers within 168 hours of sale for a full refund. If the puppy is not returned to Goshen Retrievers within 168 hours, this guarantee is void.
5. Except as separated stated below in the OFA/Eye Guarantee, Goshen Retrievers assumes no responsibility for the health of the puppy after 72 hours from the time of sale.
6. This guarantee does not cover any health issues caused by the Buyer's injury, neglect or failure to give the puppy proper medical attention.
7. All veterinary and medical expenses after the sale are the responsibility of the Buyer. Goshen Retrievers assumes no responsibility for any veterinary and medical expenses incurred after the sale.

OFA/Eye Limited Guarantee

Goshen Swamp makes the following non-transferable limited health guarantee with respect to hereditary hip/elbow dysplasia or retinal dysplasia: Within twenty-four months of sale, if the dog has not been sold or bred and if the dog develops **hereditary** hip/elbow dysplasia or retinal dysplasia as determined by a licensed veterinarian as set forth below, Goshen Retrievers will provide the buyer with a replacement puppy having value equal to the dog's original purchase price subject to the following conditions:

1. The value of the replacement puppy will be determined by Goshen Retrievers in its sole discretion. The replacement puppy will be provided when available.
2. At the time of claim, the Buyer must provide proof of AKC registration showing that the registered owner matches the buyer of the puppy.
3. For claims relating to hip or elbow dysplasia, an OFA (Orthopedic Foundation for Animals, Inc.) reading/report by a licensed veterinarian dated within twenty-four months of sale must be provided to Goshen Swamp. Goshen Retrievers has the right to require a second opinion due to variations in technique and position while x-raying.
4. For claims relating to retinal dysplasia, a reading/report by a certified canine ophthalmologist dated within twenty-four months of sale must be provided to Goshen Swamp.
5. All veterinary and medical expenses after the sale, including tests for hip/elbow dysplasia or retinal dysplasia are the responsibility of the Buyer. Goshen Retrievers assumes no responsibility for any veterinary and medical expenses incurred after the sale. The guarantee is null and void if the buyer does not provide proper nutrition, care and veterinary visits to the pup. Dysplasia due to injury, neglect, or overweight animals is not covered by this guarantee, only hereditary dysplasia.
6. This guarantee expires upon the first to occur of the following: (a) when the dog is sold, (b) when the dog is bred or (c) twenty-four months after the sale by Goshen Retrievers to the buyer.
7. All guarantee claims must be submitted to Goshen Retrievers in writing within twenty six months of sale.
8. If the Buyer is notified that a guarantee claim has accepted by Goshen Retrievers, within sixty days of the notification, the Buyer must submit veterinary proof to Goshen Retrievers that the original dog has been spayed or neutered. If the Buyer fails to do so, the guarantee shall expire and Goshen Retrievers shall have no further obligations.
9. The replacement puppy will not be provided unless and until all conditions are met within the time required.

Buy-Back Policy

If at any time the Buyer is unable to keep or care for the puppy/dog, the Buyer must contact the Seller (Goshen Swamp Retrievers) **before** selling or rehoming the dog. The puppy/dog will not be sold, traded, given away, or put in a shelter without letting the Seller know.

The puppy will be returned to Goshen Swamp Retrievers at the Buyer's expense, within a reasonable amount of time (1-3 days). The Buyer understands that he/she will not receive any money at the time of returning the puppy. If the Seller can rehome the puppy for a price, the Buyer will receive any money from the rehoming minus all costs incurred by the Seller (to include vet bills, feed costs, training time, equipment, travel, etc.). The decision to sell the puppy after it is returned is up to the Seller.

Breeding Rights

Goshen Swamp Retrievers sells this puppy with full breeding rights and full AKC registration so long as the following requirements are met. Breaking this contract will result in a **\$6,000 fine** paid by the Buyer to Goshen Swamp Retrievers.

Requirements for breeding:

- 1) Puppy will NOT be bred before the age of 2 years old
- 2) All health clearances (hips, elbows, eyes) must be performed and passed (hips must be GOOD or EXCELLENT, elbows must be GOOD/NORMAL, eyes must pass clearances) before breeding. Genetic testing for common Labrador diseases should be done prior to breeding.
- 3) No known dilute breedings will be allowed
- 4) The dog will not be bred to make a hybrid (mixed breed) dog—only to produce purebred Labrador Retrievers. This includes but not limited to: Poodles, Chesapeake Bay Retrievers, Golden Retrievers, etc.
